# **NEW ZEALAND DEFENCE FORCE – PERSONNEL ARCHIVES**

#### 20.1 Personnel Archives

NZDF Archives at Trentham Military Camp is the repository for some 1.5 million personnel files relating to 420,000 New Zealand service personnel who served in New Zealand's Military Forces. These files are an invaluable resource for documenting the social and military history of New Zealand. They provide a unique record of the military service of the men and women who defended our country at home and overseas.

NZDF Archives holds the files of all those who served in New Zealand's military forces from the 1st January 1921 to the present day.

# 20.2 South African War (1899-1902) and First World War (1914-1918) files

All of the files of those who served in the South African War and the First World War have been transferred to Archives New Zealand in Wellington.

The records can be viewed on Archives New Zealand's website, using the new search tool www.archway.archives.govt.nz/ for easier access to this information.

# 20.3 Accessing Military Service Records

Access to personnel information held by NZDF Archives is governed by the following legal provisions:

- The Official Information Act 1982
- The Privacy Act 1993
- The Health Information Privacy Code 1994

# 26.4 Enquiries About Living Former Servicemen and Women

You can request a copy of your own service record by writing to the NZDF Archives. Your request must be in writing and signed by you in order to validate the enquiry.

If you are requesting details about another living person, information can be disclosed only if you have the signed and written authorisation of the individual concerned. NZDF Archives will not release information unless you can show them this authority.

If you cannot do this because the person concerned is unable to provide this authorisation, then NZDF will need to receive a signed request from the person who holds the relevant 'Power of Attorney'. NZDF also require a copy of the Power of Attorney documents for verification purposes.

# 20.5 Enquiries About Deceased Former Servicemen and Women

Anyone can request the service records of deceased former service personnel, whether it is for a research project, your family history or your personal interest.

You can request a copy of a deceased person's service record by completing an application form: <a href="www.nzdf.mil.nz/personnel-records/nzdf-archives/accessing-military-service-records.htm">www.nzdf.mil.nz/personnel-records/nzdf-archives/accessing-military-service-records.htm</a>. You can forward the completed form to: <a href="mailto:nzdf.pam@nzdf.mil.nz">nzdf.pam@nzdf.mil.nz</a>. Please note that if the person concerned died after leaving the services this fact may not be recorded on their file. In such cases you will need to send some form of "proof of death". This could be a copy of a death certificate, newspaper death notice, funeral service sheet or photograph of the headstone. It will save time if you send this information with your initial request.

# 20.6 Charges

If you request a copy of a single military service file within a 12-month period the copy will be provided free of charge.

If you request copies of more than one military service file within a 12-month period the first file will be provided free but the second and subsequent files will be charged at the rate of \$28 per file.

You can pay via Mastercard, Visa, cheque or internet banking. To pay via Mastercard we will require your card number, name, and expiry date. We do not require your pin.

To help the records staff find the correct files, it is important to include as much information as possible about the person or persons who you want to find out about. The types of information that you should try to inform NZDF are:

- Full Name
- Any other names known by
- Date and place of birth
- Service Number
- Rank
- Navy / Army / Air Force
- Period of Service / years served
- Regiment / battalion / unit
- Next-of-kin at time of enlistment
- Address at time of enlistment
- Occupation at time of enlistment
- Whether living or deceased
- (If deceased) date of death, and if they died after leaving the Service you should send some form of "proof of death". This could be a copy of a death certificate, newspaper death notice, funeral service sheet or photograph of the headstone.

Don't worry if you cannot provide all of this information, but please try to tell NZDF as much as you can.

Whether you are writing to NZDF by letter or email, please remember to include your full name, full postal address, telephone numbers and email.

# 20.9 Viewing Original Files

If you'd like to see the original files you can book a place in the reading room at Trentham Military Camp – The Chris Pugsley Room. The staff will be on hand to provide advice and to help you decode the sometimes complex information to be found in the files. They also hold a small library of reference books that may help you in your research.

**Opening times** are: Monday-Friday, 10am-4pm, excluding public holidays.

Please note that bookings are subject to availability and must be made at least five working days in advance of your intended visit.

Use of the Chris Pugsley reading room is free but photocopying charges will apply.

# 20.10 How to get there

Travelling North along Fergusson Drive in Upper Hutt, turn right at the lights into Sutherland Ave and then continue over the railway into Messines Ave. The Trentham Camp entrance is the third turn to the left. Notice must be given to the guard hut of any visitors to camp – if you ask the staff at PAM they will advise the guard hut of your visit and provide you with a map of the camp.

# 20.12 Archives New Zealand (Refer also Annex E)

The military service files of Victoria Cross recipients and all files relating to those who left the forces up to 31st December 1920 have now been transferred to Archives New Zealand in Wellington. These include approximately 6,500 South African War files and 140,000 First World War files.

In addition, Archives New Zealand hold all of the surviving unit records and war diaries of New Zealand military forces in the South African War, First World War, Second World War and post-war operations up to and including the Malayan Emergency of 1957-1967. They also hold several important photographic collections.

The files of those who continued to serve after 1st January 1921, or who re-enlisted to serve in the Second World War, are still held by NZDF Archives.

If a WWI veteran has also done WWII service, the WWII file in many cases has been transferred to Archives New Zealand to enable a complete record to be available.

# Information Relating to Applying for Medals for deceased personne

- If you are applying for a medal for a service person who is deceased the declaration form should be completed by the person who believes they have the best legal claim in accordance with the law; the order of entitlement generally being as shown below:
  - The beneficiary under the deceased's Will
  - The legally recognised partner, i.e. Wife, Husband, Widow, Widower, Civil Union or De Facto Partner
  - Son or Daughter
  - o Grandson or Granddaughter
  - o Father or Mother
  - Brother or Sister, including Half-Brother or Half-Sister
  - Grandparents
- Note 1: When none of the above persons are still living then NZDF is able to issue the unclaimed medal(s) to

- another person named as next-of-kin in official records, step-son or step-daughter, nephew or niece, greatnephew or great-niece.
- Note 2: Family members are required to agree amongst themselves as to who will apply for and receive any unclaimed medals. Only one of each medal will be issued.
- You will be required to provide a certified copy of the following documentation:
  - Proof of relationship (e.g. full Birth Certificate including parents' names to show the link, Marriage Certificate or Power of Attorney).
  - o Notification of death (e.g. scanned copy of either Death Certificate, Death Notice, Photo of headstone or other documentary evidence the proves that the relative is deceased)\* \*Note: this is not required if the person died while on military service, or if you have previously supplied this documentation to the NZDF Personnel Archives & Medals office.
  - o The written and signed permission of the legal beneficiary of the Will or person(s) with the best legal entitlement if that is not you.

These include drawings and paintings of defence works in New Zealand, visits to RNZAF squadrons in the Pacific, documenting the post-war RNZAF (eg Lauthala Bay, Fiji, prior to closure in the 1960s), New Zealand presence in Antarctica in the 1960s and 1970s and also some material relating to New Zealand forces in Vietnam. Also various commissions for fundraising for the Museum, or commissioned by RNZAF units. We have one work by Peter McIntyre, which might qualify as Official War art but apart from that all our works are by private individuals.
