Authorisation Form & Terms of Trade Electricity & Gas Agreement

This form is an agreement between the Customer and Powerswap Limited and authorises Powerswap Limited to negotiate an Energy Supply Agreement with power and gas retailers in New Zealand.

We appoint Powerswap Limited as our exclusive electricity and gas broker for the purposes of managing a Request for Proposal (RFP)

In this regard our Gas/Power RFP will be issued within six months of the expiry of any Gas/Power agreement we may have. If we are being supplied on an uncontracted basis, Powerswap will issue our RFP within two months of signature of this form.

Powerswap is authorised by us to request all applicable data from the existing energy retailer including existing contracts, detailed usage, ICP and meter details, MHQ/MDQ data (gas), existing prices and local network charges etc.

This authority will cease to apply within 120 days of the closing date of the tender issued by Powerswap Limited. This form is also intended to comply with the requirements of the Privacy Act.

Both parties will keep all information in confidence. We agree to Powerswap fees and terms as outlined on Page 1 of this agreement. Payment is due 20th month following invoice. Debt collection fees are chargeable to the debtor.
